Most recently Dr. McDonald worked for USG Corp., a Fortune 500 company in their Corporate Innovation Center, evaluating and developing products for use in the building industry. He also trained in innovation, strategy, diversity and management. Dr. McDonald is a licensed engineer in Illinois and a Fellow of the American Concrete Institute. He is also a member of ASTM International and NACE International.
